



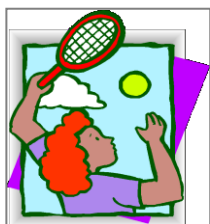
Murraywood Swim & Racquet Club

Murraywood Swim and Racquet Club is located on a private 8-acre site in the Murraywood subdivision and is owned and operated exclusively by its members. Three levels of membership are available: Pool Membership, Tennis Membership, and Full-Facility Membership which confers both Pool and Tennis privileges. Being a member of the **Murraywood Swim and Racquet Club** includes full voting rights, use of tennis and/or swimming (depending on membership plan), clubhouse facilities, and an invitation to all club social functions. **Each year, a limited number of Summer Pool Passes are available for purchase by individuals who would like to use the pool without becoming members.**



Swimming! Enjoy our huge swimming pool featuring a shallow end, a deep diving well, 1 and 3 meter diving boards, and a separate baby pool. We have a highly qualified swim team coach and Red Cross certified lifeguards. Swim lessons available!



Tennis! We are proud to have USPTA tennis professional **SEAN NORTHCOTT** on staff who is available for private and group lessons. The 4 hard and **4 clay courts** (the best in Columbia) are lighted and call-in reservations may be made. **Youth tennis clinics run throughout the year!**



Clubhouse! Our 1300 square foot clubhouse has a full kitchen, gas logs, big screen TV, and a beautiful observation deck which overlooks the courts. An active social committee provides **MSRC** families with enjoyable social events for all age levels throughout the year, and the Clubhouse may be rented by members for private social events.

Murraywood Swim & Racquet Club – Fee and Dues

Due to tough economic times the Board of Directors and members of MSRC have decided to temporarily waive the initiation fee (\$325) with the exception of “Monthly Pool Only” memberships.

POOL ONLY MEMBERSHIPS/PASSES

- Yearly Family Pool Membership** –\$385
- Monthly Family Pool Membership** – Lump sum initiation fee of \$325 and annual dues payable by bank draft of \$37.00* per month for a FULL 12 MONTH PERIOD. (Must complete attached Bank Draft Agreement).
- Yearly Family Summer Pool Pass** – Lump sum payment of \$395 with NO INITIATION FEE REQUIRED. Good for one summer only. Summer Pool Passes are only available when we are not at full membership. Must complete Liability Waiver (attached).

TENNIS ONLY MEMBERSHIPS

- Yearly FAMILY Tennis Membership** –\$575
- Monthly FAMILY Tennis Membership** – annual dues payable by bank draft of \$53.00 per month. (Must complete attached Bank Draft Agreement).
- Yearly INDIVIDUAL Tennis Membership** –\$520
- Monthly INDIVIDUAL Tennis Membership** – annual dues payable by bank draft of \$49 per month. (Must complete attached Bank Draft Agreement).

FACILITY MEMBERSHIPS (POOL, TENNIS, EVERYTHING!)

- Yearly Family Facility Membership** - \$630
- Monthly Family Facility Membership** – annual dues payable by bank draft of \$58.00 per month. (Must complete attached Bank Draft Agreement).

WAIVER AND RELEASE FROM LIABILITY FOR USE OF POOL

We, _____, HEREBY WAIVE AND RELEASE, indemnify, hold harmless and forever discharge Murraywood Swim & Racquet Club and its agents, employees, officers, directors, affiliates, successors and assigns, of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages and liabilities, of every kind and nature, whether known or unknown, in law or equity, that we, our children or our guests, ever had or may have, arising from or in any way related to my participation in any of the events or activities conducted by, on the premises of, or for the benefit of, Murraywood Swim & Racquet Club provided that this waiver of liability does not apply to any acts of gross negligence, or intentional, willful or wanton misconduct.

We understand that the activities that we will participate in may be considered inherently dangerous and may cause serious or grievous injuries, including bodily injury, damage to personal property and/or death. On behalf of ourselves, our heirs, assigns and next of kin, we waive all claims for damages, injuries and death sustained to us or our property that we may have against the aforementioned released party to such activity.

By this Waiver, we assume any risk, and take full responsibility and waive any claims of personal injury, death or damage to personal property associated with Murraywood Swim & Racquet Club including but not limited to receiving swimming lessons at the facility, using the facility, pool, and its equipment in any manner, form or fashion, and practicing and/or engaging in swimming/diving or any water activities or other related activities on and off the premises.

This WAIVER AND RELEASE contains the entire agreement between the parties, and supersedes any prior written or oral agreements between them concerning the subject matter of this WAIVER AND RELEASE. The provisions of this WAIVER AND RELEASE may be waived, altered, amended or repealed, in whole or in part, only upon the prior written consent of all parties.

The provision of this WAIVER AND RELEASE will continue in full force and effect even after the termination of the activities conducted by, on the premises of, or for the benefit of Murraywood Swim & Racquet Club, whether by agreement, by operation of law, or otherwise.

We have read, understand and fully agree to the terms of this WAIVER AND RELEASE. We understand and confirm that by signing this WAIVER AND RELEASE we have given up considerable future legal rights. We have signed this Agreement freely, voluntarily, under no duress or threat of duress, without inducement, promise or guarantee being communicated to me. Our signatures are proof of our intention to execute a complete and unconditional WAIVER AND RELEASE of all liability to the full extent of the law. We are 18 years of age or older and mentally competent to enter into this waiver.
